# EMERGENCY MANDATORY PERMIT DIRECTIVE Civil Aviation

In accordance with 22(1) of Air Navigation Order 2009 as amended the following action required by this Mandatory Permit Directive (MPD) is mandatory for applicable aircraft registered in the United Kingdom operating on a UK CAA Permit to Fly.

Reason:	A North American Aviation (NAA) P-51 aircraft experienced failure of the elevator trim tab and loss of control of the aircraft. Contributing factors were worn fiber lock spline nuts at the elevator trim tab hinge attachment fittings and the installation of non-structural screws and hardware.  Failure to comply could cause trim tab failure and consequent loss of control of the aircraft.	
Effective Date:	1 May 2013	
Compliance/Action:	Within 20 hours of operation or 1 May 2013 whichever is later, and at each 100 hours of operation, or 12 months whichever occurs first, carry out the requirements, as necessary, of Cal Pacific Airmotive Inc. SB P51-001.

#### Remarks:

- [1]. This MPD was posted on 26 March 2013 as PMPD 13-01 for consultation until 15 April 2013.
- [2]. North American Aviation Maintenance Manual AN 01-60-JE2 figure 90 contains an error. Spline nut 22D8-02 & 22ND8-02 are a 10-32 thread as stated on page 2 of the service bulletin. Figure 90 on Service Bulletin page 7 (from North American Aviation Maintenance handbook AN 01-60-JE2) incorrectly shows the installing screws to fitting #73-22007 to be a NAS220-9 & NAS220-11, which is an 8-32 thread. NAA parts books 01-60JD-4 and AN 01-60JE-4 show the proper screw #NAS221 series and 7S2-1032 series which is a 10-32 thread. P-51B & C maintenance manual NA-5913 is also correct. Please be sure to install 10-32 screws. Cal Pacific Airmotive will be issuing a correction for the NAA Service manual AN 01-60-JE2.
