NOTIFICATION OF SUPPLEMENTAL TYPE CERTIFICATE (STC) SURRENDER

This notification is issued by the Civil Aviation Authority, acting in accordance with assimilated Regulations (EU) 2018/1139 and (EU) No. 748/2012.

Background:

Tenencia limited was a UK DOA (UK.21J.0100) since 01 January 2021, prior to that Tenencia Limited held EASA DOA (EASA.21J.100) approval that was accepted as-is by the UK CAA as part of UK-EU withdrawal act. Tenencia limited, surrendered their UK DOA (UK.21J.0100) during March 2022 and ceased their operation completely. Tenencia held number of STC approvals which were originally issued by EASA and from 01 January 2021 became part of UK CAA as accepted STCs (Supplemental Type Certificates). When Tenencia limited surrendered their DOA all those STCs were also sent to the UK CAA.

This surrender is permanent and irreversible.

Affected aircraft on the UK register may continue to operate until an unsafe condition has been identified, at which point the Airworthiness Directive (AD) process will control the necessary actions. No subsequent embodiments of the design approval or release on Airworthiness Release Certificate (Form 1) of manufactured parts/articles are permitted. Aircraft operating on other registers may be subject to restrictions by the respective aviation authority.
