MANUFACTURE D'AEROSTATS Hot Air Balloons, MA-40 models only with effect

of 14 October 2020

Holder of the Certificate: NOUVELLE MANUFACTURE D'AÉROSTATS

The European Union Aviation Safety Agency (EASA) suspends on 14 October 2020 the Type Certificate for model MA-40 under EASA.BA.119 issued to NOUVELLE MANUFACTURE D'AEROSTATS in accordance with Article 77(1)(e) and 62(2)(d) of Regulation (EU) 2018/1139<sup>1</sup> in conjunction with 21.A.51 of Annex I to Commission Regulation (EC) No 748/2012<sup>2</sup> (Part-21).

The background for EASA's decision can be found in Certification Information 2020-17 which requested any possible interested persons to comment before 30 September 2020 on EASA's intention to revoke the EASA TC and/or to express their will to take over the abovementioned EASA TC.

Following the publication of Certification Information 2020-17 one person has expressed its interest in taking over the EASA TC EASA.BA.119 for the MA 40 model. Consequently EASA decided to suspend the TC instead of revoking it, in order to give that person an opportunity to demonstrate its ability to take over the TC.

As the suspension of the EASA TC EASA.BA.119 in accordance with 21.A.181(a)(3) of Part-21 affects the validity of any issued Certificate of Airworthiness (CofA), EASA requests that National Authorities having products defined in the EASA TC EASA.BA.119 on their national register to withdraw the CofA of those products, in accordance with 21.B.330 of Part-21, following the EASA decision to suspend the TC with effect of 14 October 2020.

Operators of affected balloons may continue to operate non-commercially under a permit to fly in accordance with 21.A.701 (a) 15 as "orphans".
