Andy advised re PRNAV and required timelines. Consultation must be completed by July 2012 for consultation to start in March 2013.

AJ,JB and RH raised issues regarding the routes, PRNAV against NPRs and were expecting the answers as to who is doing what,when and criteria for moving forward. RH asked what are operating benefits

- a) of PRNAV v SIDS? Any airspace benefits or just good for long journeys?
- b) LAMP 2018 Given Gatwick's and runway position how likely is a significant change?

AT replied he doesn't want 2 consultations running at same time.

- a) There are no benefits with current NPRs
- b) Few changes to benefit people.

TD summed up – meeting soon and decision to be made.

FPT report BS advised that ontrack had increased again which is good. The nightime CDA had dropped but this was due to night works on the runway.

1000 feet infringements – BS explained that FPT will make contact with the new airlines to make them aware of Gatwick practices.

JB asked if FPT has enough staff. TD advised yes. All existing staff will be cross trained.

Also noted that there seemed to be more go arounds but BS stated only showed 3 months of 2012 and probably when 12 months available it would be more comparable.

JB noted it was a good report but only showed compliance and nothing about agood practice.

RH is it possible to show runway split E/W ? BS advised can be done.

TM How do we benchmark.? TD advised WSP report showed noise management against LHR,STN and others. This should be done every 2-3 years globally. Only just received the report and will share ASAP.

TM advised ANMAC will be looking at indicators at the July meeting.

BS asked for help in locations for noise monitors. Noise web site shows reports.

RH asked for this to be kept on the agenda.

JB apologised re GAC and late email he sent. Noise monitors should show which aircraft and airline .....BS said its there if you look .... PL suggested adding links.
