<b>Continuous Descent Approach (CDA) &amp; Continuous Climb Operations (CCO)</b>		CDAs were launched at the airport in 2009. Airlines are routinely exceeding 90% CDA compliance, with a target of 96% CDA compliance set within the Noise Action Plan. CDA data is shared in the <i>Community Noise Report</i> . <b>Flight tracking &amp; tools</b>		Birmingham Airport operates a Noise and Track-keeping System (ANOMS) which is used to analysis aircraft trends and respond to community concerns. <b>Data on operations outside of normal operating hours</b>		Birmingham Airport operates 24/7 however it does have stringent night restrictions which run between 2330 – 0600 local. Night-time utilisation is reported to the Airport Consultative Committee on a quarterly basis.	
<b>Airport Consultative Committee (ACC)</b>		The airport's ACC is their primary medium for consulting with stakeholders and is normally the first external consultative body to receive information on major issues.
