DOCUMENT UPDATED ON: 31 OCTOBER 2025

The UK Air Safety List has been established to inform and protect UK citizens wherever they are in the world.

The list comprises of known states and air carriers who have failed to demonstrate that they meet relevant, internationally agreed, safety standards and as a consequence, are banned from operating into, out of or within the United Kingdom.

When making travel plans UK citizens should review the list to ensure they make an informed choice regarding all flights they may wish to make. It would be advisable to consult the provider of your travel insurance should you wish to travel on an air carrier identified in the list to see if your cover is maintained.

An air carrier which is subject to an operating ban could be permitted to exercise traffic rights to the United Kingdom associated by using wet-leased aircraft of an air carrier which is not subject to an operating ban, provided that the relevant safety standards are complied with by the relevant air carrier.
