Thank you for your request of 17 July 2018 for the release of information held by the Civil Aviation Authority (CAA). Having considered your request in line with the provisions of the Freedom of Information Act 2000 (FOIA), we are able to provide the information below.

In respect of CAP 1627, "Drone Safety Risk: An assessment",

- 1. With which organisations and individuals did the CAA consult?
- 2. What process was adopted for deciding which organisations and individuals to consult?

This was an internal study using CAA expertise and resources, it did not involve consultation with other organisations or individuals.

3. In particular which engine manufacturer is referred to in paragraph 3.17?

While the CAA does hold this information, we are unable to provide it to you. The view of this engine manufacturer was provided on the condition that the organisation was not identified. As such, disclosure of the identity of the engine manufacturer referred to would be an actionable breach of confidence. Such information is exempt from disclosure under Section 41 of the FOIA (a copy of this exemption can be found below).

4. Please provide any independent review or analysis of the study.

We do not hold any independent review or analysis of the study. As mentioned above, this was an internal study using CAA expertise and resources.

## **CAA INTERNAL REVIEW & COMPLAINTS PROCEDURE**

- The original case to which the appeal or complaint relates is identified and the case file is made available;
- The appeal or complaint is allocated to an Appeal Manager, the appeal is acknowledged and the details of the Appeal Manager are provided to the applicant;
- The Appeal Manager reviews the case to understand the nature of the appeal or complaint, reviews the actions and decisions taken in connection with the original case and takes account of any new information that may have been received. This will typically require contact with those persons involved in the original case and consultation with the CAA Legal Department;
- The Appeal Manager concludes the review and, after consultation with those involved with the case, and with the CAA Legal Department, agrees on the course of action to be taken;
- The Appeal Manager prepares the necessary response and collates any information to be provided to the applicant;
- The response and any necessary information is sent to the applicant, together with information about further rights of appeal to the Information Commissioners Office, including full contact details.

## Freedom of Information Act: Section 41

(1) Information is exempt information if-

- (a) it was obtained by the public authority from any other person (including another public authority), and
- (b) the disclosure of the information to the public (otherwise than under this Act) by the public authority holding it would constitute a breach of confidence actionable by that or any other person.

(2) The duty to confirm or deny does not arise if, or to the extent that, the confirmation or denial that would have to be given to comply with section 1(1)(a) would (apart from this Act) constitute an actionable breach of confidence.
