

Flying Display Season 2025

As the 2025 Display Season closes, we reflect on a year of strong achievements and shared learning. No significant safety trends emerged, a credit to the professionalism of all involved. Flying displays have remained at a steady rate post-COVID, demonstrating resilience and sustained interest across the sector.

There continues to be good engagement across the community, with regular interaction between all stakeholders-including the military and other regulators across the globe—ensuring alignment, transparency, and a shared commitment to Flying Display activity.

Key updates include:

- Risk Assessments Flying Display Directors (FDDs) are reminded of their continuing responsibility to mitigate all hazards-both within and beyond the display area—ensuring that risks to secondary spectators and third parties are reduced to a level that is As Low as Reasonably Practicable (ALARP) and tolerable, as per CAP 403 Appendix A.
- > Pilot Documentation Pilots are reminded that timeliness and accuracy of paperwork submissions are vital for flying display and emergency planning.
- **New Tools for DS 26**
 - A new online platform enabling FDDs to review pilot Display Authorisations.
 - A more intuitive and streamlined online flying display application form.
