I am writing in respect of your recent request of 12 May 2017, for the release of information held by the Civil Aviation Authority (CAA).

Your request:

*I would like to know the following by airport:*

- a) how many passengers passed through UK airports for 2015 and 2016*
- b) how many of those passenger traveled with reduced mobility (PRM) for the same period*
- c) how many staff are employed to physically move PRM at each airport*
- d) the duration of each PRM movement (in mins)*

Our response:

Having considered your request in line with the provisions of the Freedom of Information Act 2000 (FOIA), we are able to provide the information below.

- a) We publish passenger movement data for 2015 and 2016 on the CAA website. This information can be found in table 9 under airport data, please use the following link: <http://www.caa.co.uk/Data-and-analysis/UK-aviation-market/Airports/Datasets/>
- b) 2015 Approximately 2.75m people requested assistance (arrivals and departures combined)  
2016 Approximately 3.1m people requested assistance (arrivals and departures combined)
- c) We do not hold information relating to the number of staff employed to physically move PRM at each airport. We would suggest that you contact each individual airport directly for this information.
- d) We do not hold information relating to the duration of each PRM movement.

**CAA INTERNAL REVIEW & COMPLAINTS PROCEDURE**

- The original case to which the appeal or complaint relates is identified and the case file is made available;
- The appeal or complaint is allocated to an Appeal Manager, the appeal is acknowledged and the details of the Appeal Manager are provided to the applicant;
- The Appeal Manager reviews the case to understand the nature of the appeal or complaint, reviews the actions and decisions taken in connection with the original case and takes account of any new information that may have been received. This will typically require contact with those persons involved in the original case and consultation with the CAA Legal Department;
- The Appeal Manager concludes the review and, after consultation with those involved with the case, and with the CAA Legal Department, agrees on the course of action to be taken;
- The Appeal Manager prepares the necessary response and collates any information to be provided to the applicant;
- The response and any necessary information is sent to the applicant, together with information about further rights of appeal to the Information Commissioners Office, including full contact details.
