Thank you for your request of 29 January 2019, for the release of information held by the Civil Aviation Authority (CAA).

Your request:

1. Information detailing the specific medical equipment (Including drugs) on-board all civilian aircraft for each airline registered with the CAA.

1a. If this equipment varies between aircraft and route; can you please specify the different equipment on board each aircraft or route if applicable?

Our response:

Having considered your request in line with the provisions of the Freedom of Information Act 2000 (FOIA), we do not hold the information requested.

The CAA does not hold a record of specific medical equipment or drugs carried on individual aircraft.

However, requirements for the carriage of medical kits on aeroplanes in commercial air transport operations are detailed in [Commission Regulation \(EU\) No 965/2012](#) on air operations. The relevant text extracted from the Regulation is provided in attachment 1.

The European Aviation Safety Agency (EASA) also publishes Acceptable Means of Compliance (AMC). AMCs are non-binding standards adopted by EASA to illustrate means to establish compliance with the Basic Regulation and its Implementing Rules (such as Regulation 965/2012). The AMC relevant to your request is provided in attachment 2.

CAA INTERNAL REVIEW & COMPLAINTS PROCEDURE

- The original case to which the appeal or complaint relates is identified and the case file is made available;
- The appeal or complaint is allocated to an Appeal Manager, the appeal is acknowledged and the details of the Appeal Manager are provided to the applicant;
- The Appeal Manager reviews the case to understand the nature of the appeal or complaint, reviews the actions and decisions taken in connection with the original case and takes account of any new information that may have been received. This will typically require contact with those persons involved in the original case and consultation with the CAA Legal Department;
- The Appeal Manager concludes the review and, after consultation with those involved with the case, and with the CAA Legal Department, agrees on the course of action to be taken;
- The Appeal Manager prepares the necessary response and collates any information to be provided to the applicant;
- The response and any necessary information is sent to the applicant, together with information about further rights of appeal to the Information Commissioners Office, including full contact details.
